## **Courses**

As of November 18, we have collected 44 courses from 8 universities. If your university is offering courses, but still in the process of collecting course information from your faculties and departments, please complete the course list template that was sent to you earlier and return it to [jonasto@cuhk.edu.hk](mailto:jonasto@cuhk.edu.hk) as soon as possible so we could begin promoting your courses. For universities that have set their application deadlines in December 2020 and early January 2021, we would be grateful if you can send the course list by late November 2020.

Each university should offer no more than 10 courses and 70 places for VSE students in total. We also ask you to reserve at least 5 spaces for VSE students in each course. Each VSE student could take one course within a VSE semester. Request for taking one additional course can be entertained if approved by students' home university and the course offering universities.

To save a copy to your computer, please go to File>Save As>Download a copy. The file will be continuously updated as new course information comes in. Regular reminders will be sent by emails will be sent to inform you when there are updates.

Please consider the following after you have received the general course list:

For universities offering courses:

1. Confirm if your university would open your courses to students from all universities sending students or restrict your courses to students from your approved universities only.

For universities sending students:

1. Confirm if you would allow your students to take courses from all universities offering courses or restrict your students to take courses from your approved universities only.
2. For universities sending students] Distribute the list to your faculties and departments to seek approval for credit transferability, if needed.

By default, we will assume your university would impose no restrictions on incoming or outgoing mobility. Please contact [jonasto@cuhk.edu.hk](mailto:jonasto@cuhk.edu.hk) as soon as possible if otherwise and we will implement your restrictions in the application system accordingly.

## **Credits, Transcripts & Credit Transfer**

All courses, unless indicated otherwise, will bear academic credit provided by the course offering university. Upon successful completion of the course, a formal transcript should be issued and sent to the student's home university by the course offering university. Please contact [jonasto@cuhk.edu.hk](mailto:jonasto@cuhk.edu.hk) as soon as possible if your university is unable to provide credits or transcripts for your courses.

## **Deadlines and Dates**

As the semester starting date for each participating university varies, we have grouped the participating universities according to your indicated “deadline for VSE applications to reach your office for students to be registered before classes begin at your university” in the survey sent to you earlier. This would simplify the application workflow for both students and the VSE Central Office.

Please refer to the below table for the groupings as determined by the VSE Central Office. Applicants must submit their applications through the online application system by the stated **Application Deadlines** for each Group. Home universities must submit the list of endorsed students to the VSE Central Office ([apru.vse@cuhk.edu.hk](mailto:apru.vse@cuhk.edu.hk)) by the **Endorsement Deadlines** for each group. The VSE Central Office will then process the applications and endorsements, then send the information to the course offering universities before the deadlines indicated in the survey. ### Application Process

The application process will remain mostly the same as the previous semester, except the endorsement process will be simplified. Home universities will now submit a list of endorsed students to the VSE Central Office. Please refer to the [VSE website](#) for the application process presented to the applicants.

1. The website and course application system will be launched very soon. **Kindly dispatch the information to all your students ASAP!** Please find attached a sample publicity piece you can use and amend to suit your needs.
2. When your students submit an application on the online system, they will be asked to contact the VSE Coordinator in your office for an endorsement. Please complete the list of endorsed students ([download here](#)) and return it to the Central Office before the deadlines for each Group of universities as indicated on the VSE website. Applications MUST be endorsed by the home university before they would be processed by the VSE Central Office. Each student can take one course. Request for more than one course will be reviewed and the request will be sent to you.
3. We will send the applications together with the student transcripts to the course offering university for approval.
4. Once approved, we will inform your students and the VSE Coordinator in your office.
5. The course offering university will contact your students for formal registration and your students will start the course.

## **English Language Proficiency Requirements and Prerequisites**

Course offering universities may impose English language proficiency requirements for admission, and prerequisites for individual courses. The requirements could be found in each university's course list page on the [VSE website](#). Before endorsing your students' VSE applications, please make sure they meet the requirements otherwise their applications may be rejected by the course offering university.

## **VSE Coordinator at Your University**

The VSE Coordinator will be the main contact for VSE-related matters at your university at the student level. The Coordinator's contact will be shared on the [VSE website](#). Your students will write to this contact for endorsement on their VSE applications, while students from other universities will contact the coordinator for course enquiries.
